Sound / Media Equipment: NO CHARGE. A sound system will be provided at no additional cost in Freedom Hall. A projector and screen will also be provided in Freedom Hall. You must provide your own computer in order to run the projector. The computer must have a VGA connection to function properly. Please make sound arrangements 14 days prior to arriving at camp. Any additional sound equipment may be setup depending on availability at an additional cost.

Recreation: Groups must have a certified lifeguard in order to use the recreational lake. Qualifications must be kept on file for insurance purposes. Sports Fields, The WEE Rec Lake, Frisbee Golf, Fishing, Canoes, Paddle Boats, and other activities are available free of charge. Paintball, Zipline and Lasertag are available for an additional fee. Waters Edge Encampment must be notified of recreational activities 14 days prior to arriving at camp.

Schedule: A full schedule of events must be provided 14 days prior to the event to allow our staff to properly prepare.

The above named group agrees to the following terms and conditions:

1. A nonrefundable deposit of \$31/person and a \$100 refundable cleaning/damage deposit must be received in order to hold the date for your group.
2. Abide by all camp rules and regulations.
3. Conduct all activities at camp in accordance with the mission and purpose of Waters Edge Encampment.
4. Notify the camp of any behavior which is dangerous or outside of the mission of Waters Edge Encampment.
5. Allow no use of alcohol or tobacco on the camp premises.
6. Receive approval for campfires with the camp facilities manager.
7. Keep all buildings and facilities clean and orderly.
8. Prevent destruction and disruption of trees, plants, and all natural growth on camp property.
9. Dispose of trash as directed by the camp facilities manager.
10. Assume responsibility for damage or injury to the group's participants, the property, and structures arising from the group's use of the facilities or activities organized by the above named group.
11. **RELEASE AND FOREVER DISCHARGE** Waters Edge Encampment, its components, sponsors, agents, employees, officers, trustees and affiliates of Waters Edge Encampment, of and from any and all liability to the group, the groups assigns, heirs and next of kin, from any and all claims, demands, controversies, actions or causes of action, belonging the above named group now or in the future for any damage to or loss of group's property, and any injury to groups participants including death or any one or more of the foregoing, arising directly or indirectly out of the group's use of the camp facilities, including any damage, loss or injury caused by any act or omission on the part of Waters Edge Encampment, including any negligent conduct of Waters Edge Encampment but excluding any gross negligence or willful misconduct of Waters Edge Encampment. The above release includes the release of Waters Edge Encampment from the consequences of Waters Edge Encampment's own negligence. The only circumstance under which the release of Waters Edge Encampment does not apply is with respect to any occurrence resulting from the gross negligence or willful misconduct of Waters Edge Encampment.

The above named group understands and confirms:

1. Insurance will not be provided by Waters Edge Encampment. **All groups must submit proof of insurance with this contract.**
2. Waters Edge Encampment reserves the right to request any group member or group to leave at anytime without a return of deposit or payment.
